

# CCU Electrify Your Statements Sweepstakes

## Sweepstakes Administration

This sweepstakes is being administered and operated by Crescent Credit Union.

## How to enter

No purchase is necessary to enter nor will a purchase increase your chances of winning. You do not need to have an account or register for eStatements. If you enroll in eStatements during the sweepstakes period, you will receive one automatic entry into the sweepstakes. If you desire to enter the sweepstakes other than through eStatement enrollment, print your name, address, telephone number, and email address on a 3x5 card. Send the card to CCU Electrify Your Statements Sweepstakes, P.O. Box 4290, Brockton, MA 02303-4290. There is no limit to the number of entries you can send. Each entry must be mailed separately and cannot be mechanically reproduced. Entry must be postmarked by August 31, 2010. Entries will not be acknowledged or returned. Crescent Credit Union will not be responsible for lost, misdirected, incomplete, or illegible entries.

## Sweepstakes Period

The sweepstakes period runs from 12:00 AM ET on July 1, 2010 until 11:59 PM ET on August 31, 2010.

## Eligibility

The contest will be open only to natural born persons or permanent and lawful residents of the United States of America, and eighteen years of age or older and must not be considered a minor in your state of residence at the time of entry. The following persons are not eligible to enter the contest: (a) Employees of Crescent Credit Union and its affiliates, and (b) any immediate family members of any such employee, whether living in the same household or not, and (c) anyone living in the same household, whether related or not. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws," or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension.

One (1) grand prize winner will be randomly selected from all eligible entries.
